



PRIVACY POLICY

RS Finance Limited (Company No. 27122 BC 2024) ("the Company", "we", "our", or "us"), incorporated under the laws of Saint Vincent and the Grenadines, is committed to protecting the privacy and confidentiality of our clients' personal information. This Privacy Policy explains how we collect, use, store, and safeguard your information when you use our services.

By opening an account with us or using our services, you consent to the practices described in this Privacy Policy.

1. Information We Collect

We may collect and process the following categories of personal information:

- **Identification Data** – Full name, date of birth, nationality, and government-issued identification documents (passport, national ID card, driver's license).
- **Contact Details** – Residential address, email address, and phone numbers.
- **Financial Information** – Bank account details, payment card details, transaction history, and trading history.
- **Compliance Information** – Proof of address, source of funds, and other documents required under our Know Your Customer (KYC) obligations and the Anti-Money Laundering and Terrorist Financing Regulations of Saint Vincent and the Grenadines.
- **Technical Data** – IP addresses, browser type, device identifiers, and usage data collected when accessing our trading platform or website.

2. How We Use Your Information

Your personal data may be used for the following purposes:

- To verify your identity and comply with KYC and AML obligations under the laws of Saint Vincent and the Grenadines, including the Proceeds of Crime Act (Cap. 181) and the Anti-Money Laundering and Terrorist Financing Regulations.
- To open, manage, and maintain your trading account.
- To process deposits, withdrawals, and other transactions.
- To provide you with trading services, support, and account management.
- To monitor, prevent, and investigate fraud, suspicious activity, or breaches of our Terms and Conditions.
- To comply with legal obligations, regulatory requirements, and orders from competent authorities in Saint Vincent and the Grenadines.
- To communicate with you regarding products, services, updates, and promotions, where applicable and subject to your consent.

3. Data Sharing and Disclosure

We do not sell or rent client information to third parties. However, we may share your data with:

- Regulatory authorities and law enforcement agencies, including the Financial Intelligence Unit (FIU) of Saint Vincent and the Grenadines, as required by applicable law.
- Payment service providers, banks, auditors, and other financial institutions necessary to process your transactions.
- Third-party service providers who assist us in operating our platforms, verifying documents, or providing IT and security services.

All third parties are contractually obligated to protect your data and use it only for the agreed purpose. We do not authorise third parties to use your data for their own independent purposes.

4. Marketing and Third-Party Restrictions

- We will never sell, lease, or trade your personal data to third parties for marketing purposes.
- Promotional communications such as newsletters or special offers will only be sent if you have provided prior consent. You may opt out at any time.
- Any marketing partners or service providers engaged by us are bound by strict confidentiality and data protection obligations.
- You remain in full control of your communication preferences and may update or withdraw your consent at any time through your client portal or by contacting us at support@rs-fin.com.

5. Data Storage and Security

Client information is stored on secure servers with advanced encryption and restricted access. We implement industry-standard security measures to safeguard personal and financial data against unauthorised access, loss, alteration, or disclosure.

Access to client information is strictly limited to authorised employees and contractors who are bound by confidentiality obligations.

6. Data Retention

We retain your personal data for as long as necessary to fulfil the purposes for which it was collected and to comply with legal and regulatory requirements under the laws of Saint Vincent and the Grenadines. Generally, records are kept for a minimum of five (5) years after the end of the client relationship, unless a longer retention period is required by applicable law.

7. Your Rights

As a client, you have the following rights regarding your personal information:

- **Access** – You may request a copy of the information we hold about you.
- **Correction** – You may request correction of inaccurate or incomplete data.
- **Deletion** – You may request deletion of your personal data, subject to regulatory and legal restrictions, including our AML record-keeping obligations under the laws of Saint Vincent and the Grenadines.
- **Restriction and Objection** – You may object to or request restriction of processing in certain circumstances.
- **Withdrawal of Consent** – If processing is based on your consent, you may withdraw it at any time without affecting the lawfulness of prior processing.

Our website and trading platform may use cookies to enhance user experience, analyse traffic, and provide tailored services. Client data may be transferred to and stored outside Saint Vincent and the Grenadines, including in jurisdictions where data protection laws may differ. In such cases, we ensure that adequate safeguards are in place to protect your data, consistent with the applicable laws of Saint Vincent and the Grenadines and our confidentiality obligations.
