



RS Finance SG Cashback Promotion 2026

Introduction

- a. This Promotion, titled “RS Finance SG Cashback Promotion 2026” (hereinafter referred to as the “Promotion”) is provided by RS Finance Limited (hereinafter referred to as “RS Finance” or the “Company”), incorporated under the laws of St. Vincent (Company No. 27122 BC 2024) having its registered office at Suite 310, Griffiths Corporate Centre, Beachmont, Kingstown, St. Vincent and the Grenadines.
- b. This Promotion is exclusively available to eligible clients of our official partner Algo Venture Singapore who open and/or maintain a trading account with RS Finance and who meet the Terms and Conditions of Eligibility set out herein.
- c. By registering for, participating in, or otherwise taking part in this Promotion, the Client acknowledges that he/she has read, understood, and agreed to be bound by RS Finance’s Terms of Use, Risk Disclosure, and Client Agreement.
- d. All capitalized terms used herein that are not otherwise defined shall have the meanings ascribed to them in the Company’s Terms and Conditions.

Promotion Period

- a. The Promotion shall run from 6th February 2026 00:00 server time (GMT+2) until 31st March 2026 23:59, server time (GMT+3), unless otherwise amended or terminated at the sole discretion of RS Finance.
- b. Eligible trading volume must be completed within ninety (90) days from the date of the Client’s initial qualifying deposit.

Terms and Conditions of Eligibility

- a. Participation in the Promotion is strictly limited to individuals who are clients of Algo Venture Singapore and who are legally capable of entering into binding contracts under the laws of their country of residence. Participation is prohibited for persons under the age of 18 or otherwise deemed minors under applicable law.
- b. The Promotion is available only to verified clients of Algo Venture Singapore who have successfully opened a designated Trading Account with RS Finance, completed and passed all required KYC and verification procedures as determined by the Company, and made a minimum net fresh deposit of USD 2,000 during the Promotion Period.
- c. Employees, directors, officers, partners, introducers, affiliates of RS Finance or Algo Venture Singapore, and their immediate family members are not permitted to participate in this Promotion.

d. Participation of 'Intermediaries/Related Party(ies)' in the Promotion is prohibited. If the registration and/or deposit date and/or trading date of a participant in the Promotion corresponds with the registration and/or trading information, including but not limited to IP address, trading from the same device of another participant in the Promotion, RS Finance reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term 'Intermediaries/Party(ies)', when used in these Terms and Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the Promotion, including without limitation:

- Family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants.
- Person or entity, whom any participant in the Promotion, directly or indirectly through one or more intermediaries, controls, or whom directly or indirectly through one or more intermediaries, is controlled by or is under common control with any participant in the Promotion, for purposes of this definition, the term 'control' (including with correlative meaning, the terms 'controlled by' and 'under common control with'), as used with respect to any participant in the Promotion, shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.
- Similarly, persons associated in any manner whatsoever with RS Finance and/or with the specific websites and/or social network sites on which RS Finance may be running from time-to-time certain specific Promotion / Promotions, contest and/or surveys, in the context of which access to the Promotion is Promoted, are not allowed to participate in the Promotion..

e. This Promotion cannot be combined with any other bonus, promotion, or incentive offered by RS Finance. Any existing bonus or promotional credit must be removed prior to participation.

f. To participate and claim cashback rewards, eligible Clients must contact RS Finance via Live Chat or email at support@rs-fin.com, providing their Trading Account number and confirming participation in the "SG Cashback Promotion 2026" Submission of such request constitutes full acceptance of these Terms and Conditions.

Promotion Terms

a. Clients must deposit and maintain a minimum net deposit of USD 2,000 in the eligible Trading Account. Only Fresh Deposits qualify; internal transfers, rebates, or balance adjustments shall not be considered.

b. Any withdrawal or internal transfer during the Promotion Period shall result in the disqualified and immediate removal of all credited cashback.

c. The Promotion is applicable to one (1) Trading Account per Client only.

Cashback Rewards Structure

a. Eligible Clients may earn cashback rewards up to a maximum of USD 1,000, credited in increments of USD 250, based on achieved trading volume:

- Tier 1
 - Minimum Deposit: USD 2,000
 - Cashback: USD 250 for every 10 lots traded
- Tier 2
 - Minimum Deposit: USD 5,000
 - Cashback: USD 250 for every 5 lots traded
- Tier 3
 - Minimum Deposit: USD 20,000
 - Cashback: USD 250 for every 2.5 lots traded

b. RS Finance reserves the right to impose cashback caps and adjust tier eligibility at its sole discretion.

Cashback Credit and Claiming Rules

a. Cashback rewards shall first be credited into the eligible Trading Account as Credit once the required trading volume is achieved within ninety (90) days from the initial deposit date.

- Credit may be used as trading margin and is fully losable.
- Credit may be converted to Balance after ninety (90) days from the date the Credit is issued.
- Any negative balance at the time of conversion shall be deducted from the Credit amount. No Negative Balance Adjustment (NBA) shall apply.

b. Clients must submit a request via Live Chat or email to support@rs-fin.com to request both Credit issuance and Credit-to-Balance conversion. Approved requests shall be processed within twenty-four (24) business hours.

Lots Calculation and Trading Rules

a. Only trades that meet the following criteria shall be considered eligible:

- Eligible Instruments: Currency pairs (Forex) and Precious Metals only
- Minimum Trade Duration: Trades must remain open for more than five (5) minutes
- Restricted Trading Practices: Arbitrage, hedging, scalping, latency trading, or any toxic trading strategies are strictly prohibited

b. RS Finance reserves the right to exclude any instruments or trades at its discretion.

General Terms

- a. RS Finance reserves the right, at its reasonable discretion, to decline the participation of any client and/or to discontinue this Promotion to any of its clients, without having to explain the reasons. Such clients will be informed via email.
- b. RS Finance reserves the right to alter, amend or terminate this Promotion at its sole and absolute discretion without any prior notice. It shall be noted that participation in this Promotion constitutes acceptance and agreement to abide by any such alterations, amendments and/or changes.
- c. Any indication or suspicion, at the Company's sole discretion, of any form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from the credit trading Promotion without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a trading Promotion or any other forms of deceitful or fraudulent activity, will nullify all previously credited rebate of the Client's trading Accounts with RS Finance and/or any and all transactions carried and/or profits or losses garnered therein. Also, RS Finance shall not be liable for any consequences of the rebate cancellation, including, but not limited to, order(s) closure by Stop Out. Any suspicious activities from the client of any Partner / IB will lead to cancelling / terminating the partnership with the Partner / IB.
